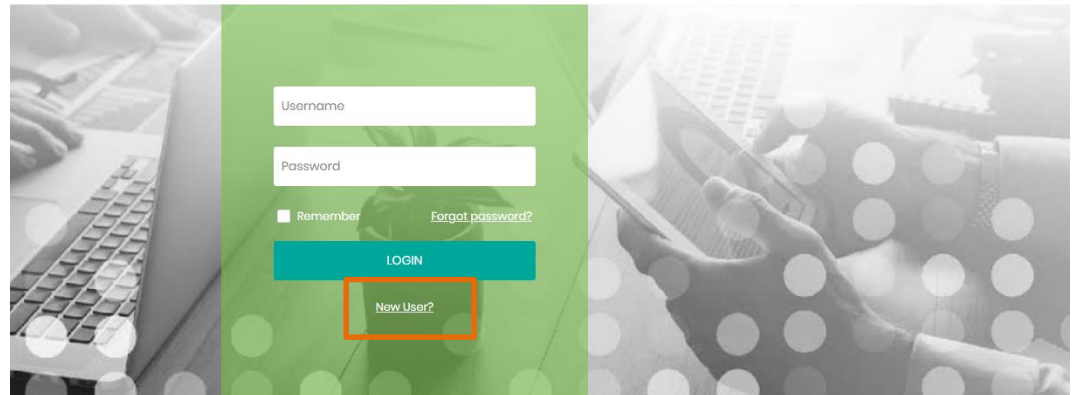

- **Check** the box to agree to the terms before clicking on the “Next” button to submit your information.

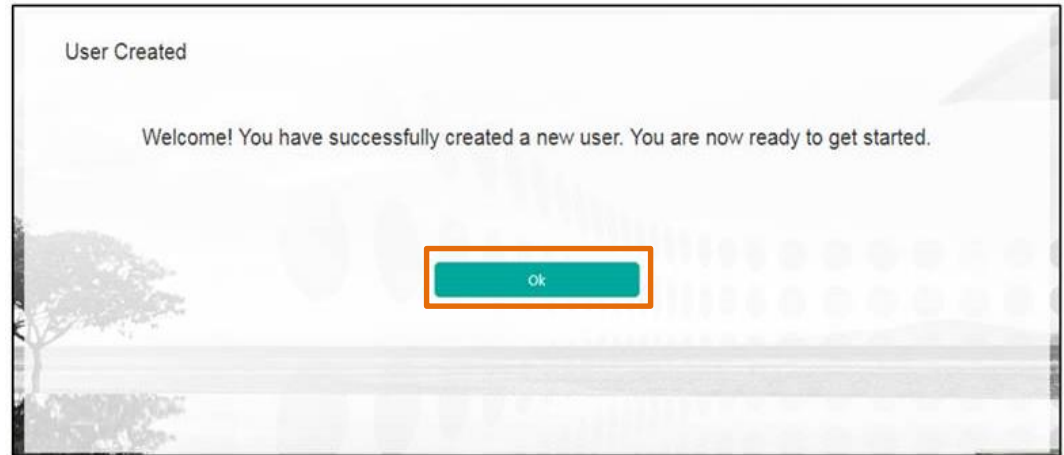
